





- Ponding and ice formation in settle areas




Poor Quality Trench Reinstatement



- Surface rupture and potholes
- Surfaces with excessive bitumen
- No sealing of joints
- Protruding ironmongery



Re: - Guidelines for Managing Openings in Public Roads (2017)

Dear Chief Executive

With reference to the above, the Department of Transport, Tourism and Sport has updated the 2015 Guidelines for Managing Openings in Public Roads. The review was undertaken by a local authority based working group on behalf of the Department and included an extensive process with stakeholders.

The Guidelines are effective from the date of this letter, are applicable to all road authorities and to all road openings.

The revised Guidelines are supported by the introduction of the MapRoad Licensing (MRL) Software, for which compliance with the Guidelines requires that all Road Licences are processed through the system. In particular, the Guidelines prescribe procedures and standards in respect of the application, approvals and closeout process together with standards relating to the work of opening, backfilling and the reinstatement of road surfaces. The Guidelines also set out a summary of the legal framework relating to the powers of road authorities, various statutory bodies and private individuals involved in carrying out openings in public roads.

Please note that some aspects of the Guidelines will be subject to 'phasing in arrangements' and, therefore, will only apply as and when they become available. In particular the following are subject to phasing in arrangements: -

- Training for Advanced Trench Reinstatement (Approved Certifiers) and Basic Level Trench Reinstatement,
- Use of mobile apps and Site Photographs,
- Timelines (including turnaround times),
- Charges,

Details of the 'phasing in arrangements' arrangements, along with associated timelines will be available from the Road Management Office (RMO). The RMO will provide assistance to Local Authorities in the implementation of the Guidelines over the coming months.
